



NOTICE ABOUT EXTENDED RESULT OF
ARS (Preliminary) Examination – 2015 and Rescheduling of ARS Mains Examination
on 08.05.2016

The Board had notified result of ARS (Preliminary) Examination- 2015 vide Result Notice No.1(1)/2015-Exam.II dated 04.02.2016. As the Examination was conducted in more than one slot in some of the disciplines for which multiple sets of question papers were used, representations were received in the Board to regulate result in such disciplines by application of EquiPercentile Normalisation procedure to make up for the difference in the difficulty level of different sets of Question Papers.

Hence, in terms of enabling provision notified in the Exam notification dated 9th October, 2015 under “detailed plan of Examination for ARS 2015” [Appendix-VI] wherein it has been provided that “the Board reserves the right to fix/alter the qualifying marks and ratio in any or all disciplines at its direction”; and after considering all aspects, the Board has approved revision of the result declared earlier by applying EquiPercentile Normalisation, where-ever practicable and by enlarging the qualifying ratio from 1:15 to 1:43 (category-wise) for each post to give the candidates more broad opportunity to make up for the difference in the difficulty level, if any. In the process, the number of candidates shortlisted for appearing in ARS Mains Examination- 2015 have increased from 1141 to 2217.

Candidates can download their revised result from the link available on ASRB's website www.asrb.org.in using their Roll No. and Date of birth (as entered at the time of online form submission)

The percentile/percentage secured by the last qualified candidate for ARS (Mains) Exam-2015 under each discipline are given in the attached Annexure-I.

The Board has also decided to reschedule the ARS Mains Examination on 08.05.2016 with a view to give all the shortlisted candidates sufficient time for preparation for the Exam. Further, the date of submission of documents/certificates by the qualified candidates in the revised result is also extended from 07.03.2016 to 28.04.2016. In case of non-submission of documents/certificates by the qualified candidates, the candidature of such candidates will be rejected.
