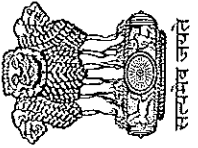

Online Tender bids are hereby invited on behalf of the Secretary, Agricultural Scientists Recruitment Board, New Delhi for Outsourcing Typing, Stenographic, Dairy/Dispatch And Related Clerical Services With Proficiency In MS Office On Contract Basis at 32 points per day per month for a period of one year at ASRB located at Krishi Anusandhan Bhawan-I, Pusa Campus, New Delhi-110012 extendable by one more year subject to satisfactory performance of the vendor and mutual consent.

1. The terms and conditions of the contract are those contained in the general conditions of contract applicable to the contracts placed by the ASRB, as detailed in the tender forms and its schedules. Please submit your rates in the online tender form if you are in a position to furnish the requisite services in accordance with the requirements stated in the attached schedules.
2. An earnest money of ₹.2,00,000/- must be deposited in the form of demand draft/pay order payable to Secretary, ASRB at New Delhi in person to Section Officer (Gen Admn.) in Room No. 101, Krishi Anusandhan Bhawan-I, Pusa Campus, New Delhi on or before the last date/time of submission. The particulars of the earnest money deposited must also be super-scribed on the top of the envelope by including the draft/pay order number and date, failing which the bids will not be accepted. Conditional bids shall not be

considered. No overwriting or cutting is permitted in the tender documents. Such bids will be rejected outright.

3. The tenderer is being permitted to give tender bid in consideration of the stipulations on his part that after submitting his tender bid, he will not resale from his/her offer or modify the terms and conditions thereof. If the tenderer fails to observe and comply with the foregoing stipulations the aforesaid amount of EMD will be forfeited by the Board. In the event of the offer made by the tenderer not being accepted, the amount of earnest money deposited by the tenderer will be refunded to him after he has applied for the same, in the manner prescribed by the Board. An undertaking as per **Annexure-II** is also required to be submitted by the tendering firm.
4. The schedules of the tender form should be uploaded with online bids. In the event of the space provided on the schedule form being insufficient for the required purposes, additional pages may be added. Each additional page must be numbered consecutively and be signed in full by the tenderer. In such cases reference to the additional pages must be made in the tender form. If any modification of the schedule is considered necessary it should be communicated by means of a separate letter alongwith the tenders.
5. The tender bids are liable to be ignored if complete information as required is not given therein or if the particulars asked for in the schedules to the tenders are not dully filled in. Individual signing the tenders or other documents connected with the contract may specify whether he signs it in the capacity of (i) a sole proprietor of the firm of constituted attorney of such sole proprietor, or (ii) a partner of the firm if it be partnership in which case he must have authority to refer to arbitration dispute concerning the partnership whether by virtue of the partnership agreement or power of attorney or (iii) constituted attorney of the firm if it is a company.
6. If a tenderer does not accept the offer, after issue of letter of award by ASRB within 15 (fifteen) days, the offer made shall be deemed to be withdrawn without any notice & earnest money will be forfeited.
7. In case of partnership firms, where no authority has been given to any partner to execute the contract/ agreement concerning the business of the partnership, the tenders and all other related document must be signed by every partner of the firm. A person signing the tender form or any other documents forming part of the contract on behalf of another shall be deemed to warranty that he has authority to bind such other person and if, on enquiry it appears that the persons so signing had no authority to do so, the Board shall without prejudice to other civil and criminal remedies may terminate the contract and hold the signatory liable for all costs and damages. Each page of the tender and the schedules to the tender and annexure(s), if any, should be signed by the tenderer.
8. Online tenders are invited under two-bid system through e-procurement system. EMD & tender form cost must be deposited with Section Officer (Gen. Admn.) during working hours i.e. 9.00 A.M. to 5.30 P.M. on all working days (except Saturday, Sunday and Gazetted Holidays) before the last date/time for submission of bids failing which bids will not be accepted. EMD must be in the form of Demand draft/Pay order payable to Secretary, ASRB at New Delhi.
9. The rates quoted by each firm for job/service contract in tenders be given both in words and figure failing which the same is liable to be rejected. Tenders will be opened online by the authorised officer. Bidders have two options to participate in tendering process

at the time of opening of Bids. Bidders can come at the place of opening of bids (electronically) as done in the conventional tender process or he can visualize the process online without physically being present at ASRB premises.

10. Tenderer is at liberty to be present or to authorize a representative to be present at the time of opening of the tenders. The name and address of the representative who would be attending the opening of the tenders on behalf of tenderer should be indicated in the tender. Name and address of permanent representative of the tenderer, if any, may also be indicated.
11. **An amount equivalent to 7.5% of the estimated value of contract** is to be deposited by the selected agency/ successful tenderer as Performance Security Deposit only after receiving a communication from the Board. In the event of non-deposit of the same, the earnest money will be forfeited.
12. No interest on security deposit and earnest money deposit shall be paid by the Board to the tenderer. The rate should be quoted in Indian Rupees only and it should be valid throughout the period of contract.
13. The Contractor will be reimbursed for each manpower at the consolidated rates as detailed in **Annexure 'A'**. The tendering agency shall be responsible for compliance of all statutory provisions relating to minimum wages, EPF & ESIC in respect of personnel deployed by it to this office.
14. The Firm will not charge placement charges on any other account from the manpower deployed with the Board. The contract is liable to be terminated, security deposit forfeited and the Contractor/Firm will be blacklisted if, at a later stage, reports are received that the Contractor/Contracting Firm has charged any placement charges from the manpower on any account.
15. The tax as per the Govt. NCT of Delhi shall be deducted at source from monthly bills of the successful tenderer, as per rules/ instructions made applicable from time to time by government.
16. In accordance with O.M. No. 29(1)/2014-PPD dated 28.01.2014 of Department of Expenditure, Ministry of Finance, bids quoting 'Zero' consideration/service charges or its derivatives shall be treated as unresponsive and will not be considered.
18. Secretary, ASRB reserves the right to reduce or terminate the period of contract or to extend its duration in the interest of the Board, for any justifiable reasons and it is not mandatory to be communicated to the tenderer.
19. Decision of Secretary, ASRB shall be final for any aspect of the contract and binding to all parties. Disputes arising, if any, on the contract will be settled at his level by mutual consultation and in case of failure or settlement dispute shall be referred to the sole arbitrator to be appointed by the Secretary, ASRB. The decision of the sole arbitrator so appointed shall be final and binding on the parties. Arbitration proceeding shall be governed by the Arbitration & Conciliation Act, 1996 as amended from time to time.
20. Acceptance by the Board will be communicated by fax, express letter, e-mail or any other form of communication. Formal letter of acceptance and work order of the tenderer will be forwarded as soon as possible, but the earlier instructions in the fax, express letter, e-mail etc. should be acted upon immediately.

21. The Board does not pledge itself to accept the lowest or any other tender bid and also reserve to itself the right of accepting the tenders whole or in part keeping in view valid reasons. Conditional bids will not be accepted.
22. The Board, in its capacity as Principal Employer, reserves the right to modify any of the terms and conditions of the contract as mentioned in the Schedules I & II of this document, at its discretion, in the interest of the job/work.
23. Successful Bidder/tenderer will have to enter into a detailed contract agreement with ASRB on non-judicial stamp paper of Rs. 100/- (One hundred only) for work.

GENERAL INFORMATION & OTHER TERMS & CONDITIONS OF OUTSOURCING TYPING, STENOGRAPHIC, DIARY/DISPATCH AND RELATED CLERICAL SERVICES WITH PROFICIENCY IN MS OFFICE ON CONTRACT BASIS AT 32 POINTS PER DAY PER MONTH FOR A PERIOD OF ONE YEAR AT ASRB PREMISES, KRISHI ANUSANDHAN BHAWAN-I, PUSA CAMPUS, NEW DELHI-110012 & EXTENDABLE BY FURTHER ONE YEAR SUBJECT TO SATISFACTORY PERFORMANCE & MUTUAL CONSENT.

A. Scope of Work:

The services as detailed below are to be provided to the Sections/ Senior officers of ASRB located at Krishi Anusandhan Bhawan-I, Pusa Campus, New Delhi:

- (i) Typing/data entry/stenographic work/diarizing/despatch of letters/receipts filing/docketing of papers.
- (ii) Other miscellaneous work of similar nature as and when allotted by concerned Sections/Officers.
- (iii) Upkeep/arranging of files in the section.
- (iv) Photocopying of papers etc. and making sets, as required.
- (v) The services are to be provided for 5 days a week from 9.00 A.M. to 5.30 P.M. In exigency of official work, if services are required to be rendered on Saturday and Sunday including holidays etc. then wages will be paid as per norms of NCT/Central Govt. In case services as required beyond office hours then wages will be considered as pro-rata basis and will be reimbursed to vendors accordingly.

B. Terms & Conditions:

- i. The manpower deployed shall follow strict attendance and alternative arrangements are to be made by the agency whenever any of manpower goes on leave under intimation to this office.
- ii. Changing of manpower should be in consultation with Under Secretary (Genl. Admn.), ASRB.
- iii. The Secretary, ASRB reserves the right to reject any or all quotations in whole or in part assigning reasons therefore. The decision of Secretary, ASRB shall be final and binding on the contractor/ agency in respect of clauses covered under the contract.
- iv. The manpower provided shall maintain secrecy and discipline in the premises of ASRB, Krishi Anusandhan Bhawan-I, Pusa Campus, New Delhi.
- v. The manpower provided shall be capable of reading and writing Hindi and English with a minimum qualification of graduate from any recognized University with knowledge of MS Office and a healthy typing speed.
- vi. The Contractor shall keep a complaint register with his representative, and it shall be open to verification by the authorized officer of ASRB for the purpose. All complaints should be immediately attended to by the Agency.

- vii. The agreement is terminable with one month notice on either side. In case of termination of this contract on its expiry or otherwise, the personnel deployed by the service provider shall not be entitled to and have no claim for any absorption in the regular/otherwise capacity in ASRB.
- viii. The contractor shall not sublet the work without prior written permission of the ASRB.
- ix. The monthly pay of the contractual manpower will be paid as per consolidated wages as given in Annexure 'A'.
- x. The contractor or his workers shall not misuse the premises allotted to them for any purpose other than for which the contract is awarded.
- xi. The selected agency shall provide the necessary personnel at ASRB premises as per labour laws prevalent in NCT of Delhi. The agency shall employ adults only who are good and reliable persons with good health. In case any of the personnel so provided is not found suitable by the Board, the Board shall have the right to ask for his/her replacement without giving any reason thereof and the agency shall have to replace such personnel immediately.
- xii. The personnel so provided by the agency under this contract will not be the employees of the Board and there will be no employer-employee relationship between the Board and the persons so engaged by the contractor in the aforesaid services. They shall be the employees of the contractor for all purposes.
- xiii. Payment of wages to the firm shall be made by RTGS. Payment for service contract will be made upon submission of pre-receipted bill along with attendance sheets of the manpower, payment vouchers duly signed by contractual employees and EPF and ESIC challans for submission of EPF/ESIC contribution for each month.
- xiv. The tenderer should indicate only the lump-sum amount in respect of all the services covered under this contract and that rates shall not be proposed on the basis of manpower to be deployed under the contract. No request for alteration in the rates once quoted will be entertained within the period the contract is in force.
- xv. The rates to be quoted shall include cost of each and every item including transportation cost, manpower cost etc. Monthly wages should be as per the Minimum Wages (monthly- graduates and above category) prescribed by Govt. of NCT of Delhi. **Bids quoting 'Nil' consideration/service charges or its derivatives shall be treated as unresponsive and will not be considered for evaluation.**
- xvi. The contractor will discharge all his legal obligations in respect of the workers/ supervisors to be employed/deployed by him for the execution of the work in respect of their wages and service conditions and shall also comply with all the rules and regulations, provisions of law in force that may be applicable to them from time to time. The contractor shall indemnify and keep indemnified the Board from any claims, loss or damages that may be caused to it on account of any failure to comply with the obligations under various laws. In case of any dispute, the decision of Secretary, ASRB shall be final and binding on the contractor.
- xvii. Income Tax in respect of individuals will be deducted from the payment due for the work done as per rule. TDS from the monthly payment to contractor will be deducted as per rules applicable from time to time.

xviii. The selected agency shall provide the necessary personnel at the ASRB as per labour laws prevalent in the NCT of Delhi. The agency shall employ reliable persons with good health in the age group of 21 to 45 years. In case any of the personnel so provided is not found suitable by the Board, the Board shall have the right to ask for replacement without giving any reason thereof and the agency shall have to replace such personnel immediately.

xix. Service charges are to be mentioned separately by the tendering firm.

xx. The manpower deployed to this office by the Contracting agency will be adjudged for their suitability for this work by the Board.

xxi. **Risk Clause:** ASRB reserves the right to discontinue the service at any time, if the services are found unsatisfactory by giving a show-cause to be replied within a week and also has the right to award the contract to any other agency at the risk and cost of current agency and excess expenditure incurred on account of this can be recovered from Security Deposit or pending bills or by raising a separate claim.

xxii. The service provider agency shall be solely responsible for the redressal of grievances/resolution of dispute related to personnel deployed and Board shall in no way be responsible for settlement of such issues whatsoever.

xxiii.
